The MUTC map is near completion.

Carol visited the Audobon Society. She showed maps on the Auburn Trail and a possible trail to connect to the Auburn. We would need to cross a creek. They do not want an entrance to their park from the Railroad Mills Rd..

Dave, Carol and Larry need to walk it soon.

A meeting with the Burtons is still needed to dicuss a connection from Pipers to Royal View Heights.

Trailboss Report:

Larry received a letter from MRB, engineering. No dollar amount was quoted but they recommended that we stabilize the area around the creek and bridge. Larry will submit the 3 bids to the DOT for their review. Explorer Post 295 from Bloomfield cleared all of the Royal View Heights trail. Larry will send them a thank you letter for the great job.

The Lehigh Trail sign committee liked Larry's sign the best.

Discussion on use of trails for snowmobiles was held. In Mendon and Rush, a snowmobile club asked permission to use the Lehigh Trail in Monroe County. A public hearing will be held March 4 for public input at the Mendon firehouse. The Mendon town board passed an ordinance against snowmobiles. After some discussion, it was agreed upon by the members present that we allow no snowmobiles on our trails. A letter will be sent to Mendon and Rush stating that we are not in favor of opening the Lehigh to snowmobiles.

The DOT will install a pedestrian sign on rte. 251 at Cork Rd.; it will be a large sign due to the curve which limits a driver's view when coming from Mendon.

Adopt-a-Trail:

We need to make signs recognizing those who have volunteered to maintain the trail. Dave made prototypes which were about 3"X5" to be made of laminated paper and placed on a post on the trail.

Last Hike:

Six people hiked Boughton Park on Feb. 8. It was a bit slippery but beautiful.

Book Sale:

We have sold one more book.

New Business:

Cobblestone Creek Subdivision Section IV was asked by the Planning Board for a conservation easement. It was agreed to use the wooded area.
