Jack Bauer, Town Highway Superintendent, has a small bulldozer for clearing and leveling the large stone along the Auburn and Lehigh Trails. He will try to have the work done the week of Oct. 27, 1997.

Last Hike:

A beautiful day was provided for the Sat., Oct. 11th hike on Stid Hill. The view from the Bristol Hills overlooking Canandaigua Lake was spectacular; foliage was at or near peak. Several new hikers accompanied some of the regulars for a total of 10.

Old Business:

Nine members and Kaman joined Marcia Bryan for two days of exhilarating hikes in the "medium" peaks of the Adirondacks. Blue sky prevailed Saturday.
