They have a good plan. Carol needs to talk to the land owners.

The preliminary plans for the Drumlin apartments show a hiking trail around the perimeter.

The Neubert land (one acre) on Plastermill Rd. has been accepted by the town as a wildlife habitat with a scenic vista. Joan A. Neubert made the donation.

The Town has been asked if it would like to purchase a parcel of land adjacent to the Fishers Park on Wangum Rd.. There will be a public hearing at the Town Hall on Monday, Feb. 14, 7:30PM.

# **Charlene Berry-Pickering:**

Charlene is thrilled with her appointment to Parks and Recreation Director of Victor. She comes to our area with a diverse background in both recreation and the outdoors. Charlene supports the efforts of VHT. Currently, with the help of the town, she is looking into getting office space in the former Victor Jr. High. Larry will try to reach Debbie Wegman regarding the RG&E property on Dryer Rd. John McVay is getting prices on materials from Victor Coal and Lumber. He must have his proposal approved by the District Advancement Chairman and should begin the end of March, beginning of April.

There were approximately 10 hikers who enjoyed the sunny day in the Genesee County Park. They had lunch in the new Visitor's Center and returned to Victor around 2:30 PM.

## **Old Business:**

On Sat. Jan.  $8^{\text{th}}$  , 7 members attended the annual breakfast kick-off meeting at Brenda's Restaurant.

### **New Business:**

Dave W. received a brochure of the NY State Biking and Hiking in the Finger Lakes Region. It includes Monkey Run Trails, Auburn, Lehigh and Seneca Trails. He also has a Wayne County Travel Guide and an ADK Genesee Valley Chapter brochure.

Crescent Trails has updated their master plan and map. It includes a proposed connection from their conceptual southeast loop of the Crescent Trail to the northern terminus of our Seneca Trail at Valentown Museum. Dave W. has an application for a Community Millennium Trail. It is recommended that we submit the Seneca Trail as a candidate because of its historical significance and because we are planning to hike it on June 3, 2000, National Trails Day.

Dave W. sent a thank-you letter on behalf of VHT to the town to give to Alice Hunt at her retirement party on Jan. 14.

A letter was sent to the Town Clerk asking permission to meet at the Town Hall on the fourth Thursday of each month, except Nov. and Dec. when the third Thursday was requested. We will continue to meet in the main room at 7:30PM.

April 22 is Earth Day. We should try to plan a special trail cleaning sweep.

The next BPAC meeting is Thursday, Feb. 10, 2000. Dave W. is planning to attend.

The county has aerial photos that can be tied into the GIS. The cost to Victor for the full complement would be \$10,000. The town is considering a purchase.

Chris Hart is Chairman of the Planning Board.

Bernie McCarthy is Chairman of the Conservation Board.

Marge Elder was appointed to the Conservation Board.

Charlene Berry-Pickering is Director of Parks&Recreation.

Dick Bottorf is Chairman of the Growth Management Committee.

Dave W. was asked to be on an advisory committee to the Victor Historical Society to make recommendations regarding the Zoe Smith property on the corner of High St. and rte. 96 across from Pizzeria Uno. More meetings will be held before recommendations are made.

The Town has paid the premium for our special insurance rider. Dave W. has the policy.
