### **Publicity:**

Dave Wright updated the voice mail line and sent faxes to the local newspapers regarding our June 1 bike ride on the Auburn and our June 8 hike at Fishers Park. Ruth suggested that we include the length and degree of difficulty of the hike so people know what to expect.

#### Historian:

Glen McHargue continues to organize the newspaper clippings. Submitted were several articles on the library talk, waterfalls in the area, upcoming hikes and a map of a 46 mile paved trail in Flordia.

## **Education:**

Ruth Nellis submitted an article for the newsletter on how to select a bicycle. She also contacted the Association for the Blind and Visually Impaired regarding Braille signs for a nature trail at Fishers Park. She will be getting more information next week. The signs need to be weather resistant.

#### **Newsletter:**

The summer issue is roughed out. We need photos of Adirondacks, monthly hikes, eagle bridge, etc. Larry submitted a CD with lots of spring 2002 pictures. The newsletter will be mailed on 5/29/02.

#### **Trail Master:**

Ruth and Carol have been working very hard to get permission for a trail from Ganondagan to Boughton Park. They have a signed revocable permit from Mr. Bahai (Apple Farm). They talked to Mr. And Mrs. John Duvall on Rt. 444, just over the Victor town line. They would like to walk where we suggest the trail should be located. Carol is still trying to get an appointment with Peter Jemison. Two other property owners are thinking about the permission for the trail.

#### **Trail Boss:**

Dave Wright met with Pactiv and Omnitech landowners (MCA Group, LLC) regarding an access path from the building parking lot to the Auburn by Phillips Rd. MCA will consult with the engineers and come back with a proposal.

**Pactiv** has 30 employees available for trail clearing on Friday June 7. Dave suggested we clear the trolley trail from Rt. 251 to the connection of the Seneca and Auburn. All agreed this would be a great addition to the trail. Dave W. needs to send a letter to the property owner in New Jersey to get permission.

Larry F. suggested we mow **Ganondagan** on Saturday, May 25. Meet at the RG&E substation on Dryer Rd at 8 a.m. Larry will take care of the Auburn between Phillips and Probst Roads at his leasure.

Dave W. suggested that we mow the path in the Hamptons by the pond near **100-Acre Woods** on Monday, May 27 at 8 a.m. Meet at the end of Yale Court near the detention pond.

Dave W. is planning to meet with Douglas and Sheldon Fisher at the tennis courts at Fishers Park on Sunday, May 26 at 2 p.m. to view and discuss the plan for the "FISHERS" stones on the hill above Larry's house.

**Last Hike:** 19 hikers drove to Dresden and hiked the Keuka Lake Outlet Trail on a gorgeous sunny day. They returned to Victor at 3:45 p.m.

#### **Old Business:**

Eight people drove to Marcia Bryan's house for dinner on May 3 and a great hike of the Tongue Mountain Range on May 4. This 15-mile hike on the ridge overlooking Lake George took about 11 hours to complete. It was a leisurely hike with many stops for food, drink, views and rest. Everyone enjoyed a wonderful steak dinner in Bolton Landing. On Sunday it was a short hike to the Blue Heron rookery followed by a restful ride back to Victor.

Dave Wright, Charlene Berry-Pickering and Rich & Sue Freeman gave an informative talk about Victor Trails, Victor Parks and waterfalls in western NY at the Victor Free Library on Wednesday, May 22. One free VHT membership was included in the raffle.

Chris Sonnefeld from Troop 50, Farmington, continues to work on the plan for a bridge for the connection of the Auburn and Lehigh Crossing Park. He needs to take care of special paperwork because the DEC has determined that the creek is a trout stream. Chris raised \$427.50 selling donuts to local businesses to help pay for the materials. The balance of the cost will be split between VHT and Victor Parks and Rec.

Genesee Region Trails Coalition continues to plan a Hike and Bike Ride, meeting at Genesee Valley Park on October 6<sup>th</sup>. Also, Victor Parks and Rec. has joined the coalition.

least one person joined as a result of our presence. Three gift certificates for VHT membership were also raffled off at the end of the day. One of the winners was the cochairman of the event.

The Finger Lakes Hiking and Biking Guide has been updated and reprinted. May of our trails are mentioned.

The Penfield Trails Committee has produced a new trail brochure and map.
