SAFTEA-LU Transportation Enhancement Program (TEP)- Town of Victor applied for a \$885K grant to extend the Auburn Trail from Main Street Fishers to Powder Mills Park The bulk of the cost is for the refurbishing of the stone arch bridge over Irondequoit Creek.

Fat Tire Festival was a great success. Over 100 participants and many spectators/bicyclists. Parking lot was full. Chicken BBQ sold out. Rain in the morning, but afternoon was sunny.

Genesee Region Trails Coalition has a new Grant program. Dave and Brian submitted an application to add new decking and railing to the Lehigh Trail trestle over the Auburn.

New Business

Erie Canal Greenway Grant Program. \$6M is available for the canal corridor to preserve and rehabilitate canal infrastructure, enhance recreational opportunities and promote tourism, historic interpretation and community revitalization.

Empire Pipeline construction is delayed due to scheduling with other related projects.
