



## Victor Hiking Trails, Inc.

### Meeting Minutes, September 23, 1992

The meeting was called to order at 7:34 PM. Ten people were in attendance. The minutes from the previous meeting were accepted as written.

#### Hang Around Victor Day:

All agreed this was a resounding success. So far we've gotten 3 new family memberships and 2 individual memberships as a result. We succeeded in spreading the word and increasing awareness of VHT in the general community. Thanks to Dave Wright for an excellent job organizing and coordinating this event.

#### Future Trail Possibilities:

Marcia Bryan reported that the Planning Board met on Sept. 8th. She voiced a request for a trail easement through the Gillis Rd. subdivision. The Sept. 14th walk of Cobblestone Creek (to see the proposed trail route) was cancelled. It will be rescheduled.

Larry Fisher asked if an eagle scout could work on a project to develop a trail from behind the Fisher's firehall, across the creek, and over to Fisher's park. The members in attendance unanimously approved this project. We wish the scout well and will certainly do anything we can to assist him.

#### Treasury:

Allen Johnson reported we have \$288 in the bank plus \$40 in new members for a total of \$328. Larry Fisher reported that our scheduled work detail turned into a very pleasant hike. We were unable to work on the trail because we hadn't gotten clearance from RG&E in time.

#### New Member Letter:

#### Nominating Committee:

A nominating committee consisting of Jeff Hennick, Rich Freeman, and Roberta Lockwood was approved by members present. They will bring a slate of candidates to the October meeting. We'll vote at the November meeting. Jeff asked the board members present if any would prefer to not be renominated. (no one spoke up which must mean - we all love our jobs!!) Allen suggested that the committee check with all people they name to the ballot before the October meeting.

By-laws:

Sue Freeman passed out the revised by-laws for everyone to review. Please bring any comments to the October meeting. Jeff Hennick made the very astute observation that our annual meeting is listed in the by-laws as the day before Thanksgiving. At the October meeting we'll vote on moving the annual meeting to the third Wednesday of the month.
