

VICTOR HIKING TRAILS, INC. Meeting Minutes July 28, 1993

The meeting was called to order at 7:40PM with 5 members in attendance.

Revisions/Additions to Previous Minutes:

The next monthly meeting was published as being July 24 instead of July 28.

Under Revisions/Additions, the last sentence should read "and the land owned by the North Bros. is on the west side of School Street."

Ken Christy and Jeff Hennick should be recorded as agreeing to assist the Trail Master, as Ron Czadzeck is unable to at this time.

Trail Boss:

Trails are being kept open. From 1 to 5 members have been showing up to help cut grass and weeds.

A letter was sent to Debra Wegman with the plans for the proposed bridge to go over Irondequoit Creek; her response was optimistic. Jack VanVorrhis is willing to give us a power line tower for use in constructing it.

Sign Committee:

Estimates for trail signs were too high for our budget. Larry Fisher will use acetate sheets with the information printed on each. These will be affixed to a board that will, in turn, be mounted on a post.

Authorized Trail:

June 28, 1993 - the Town of Victor's Board authorized the trail agreement between the Victor Hiking Trails, Inc. and Richard and Margaret Ryon. The official opening will be Sat., Sept. 18.

Hang Around Victor Day:

Lenore Dey will be chairperson, organizing our participation in this annual event. Our booth will have the same location as last year. Select your favorite recipes for baked goods, fudge, candy, etc. to donate for our fund raising.
