Trail Master: (Carol MacInnes)

Cobblestone Creek - Carol, Dave C. and Dave W. hiked and tagged a trail at the top of the development on Saturday, March 15. It looks like it is possible to have a trail between the homes at the bottom of the hill and the proposed homes at the top of the hill, without seeing either. Dave W. called BME to set up a walk with the developer. No date set yet. Dave will call when a date is available.

Last Hike:

12 cross-country skiers drove to Harriet Hollister for a beautiful, sunny morning of skiing some nicely groomed trails.

Old Business:

Lehigh Crossing Park Bridge- No report. Spring Bike Event- Cancelled. Monkey Run Trail- Property has been surveyed and staked. Jim Mattoon needs to level the trail surface.

Turner Subdivision- Trail has been approved around the property line.

National Trails Day- We received our first applicant- Dan Wilson from Spencerport.

Seven members hiked from Dryer Road Park to Fort Hill to Ganondagan to Mickey Finn's. It took two hours and ten minutes on icy trails with not many rest stops. A few muddy spots will be encountered on June 7.

Dave W. hiked from Mickey Finn's to Brace Road to Brace Road Park to Mead Square. That took one hour at a leisurely pace. We expect fast hikers will do the five miles in 3 hours and some will take 4 hours. Stragglers may take 5 hours.
