Trail Boss' Report:

• Larry reported that RG&E is working on the Auburn Trail between Route 251 and Rawson Road. They are replacing power lines. They have widened the trail to get equipment in.

- More people have been coming out for trail maintenance.
- Larry has seen more people using the trails. This is good!
- We need signs on the Auburn Trail to show bicyclists the route on School and Maple Street to get around Great Brook and the route on Brace, Break of Day and East Victor Roads to get around the creeks.
- Both stone bridges west of Fishers have more erosion at the base due to heavy rains. Larry suggested that the bridge be taken down and use the stone as a retaining wall. More discussion is required.

Last Hike:

14 people hiked up Conklin's Gully at Hi Tor, near Naples. It was a warm sunny morning with clear, cool water in the creek. We had lunch at the top of the hill. Great views of the south end of Canadaigua Lake and the Bristol Hills.

New Business:

- One Victor History book sold.
- Dave W. rec'd. a call from Beth Kossof of the Ontario-Yates Hospice in Geneva. They would like to have a fund raiser hike next spring or fall. Dave sent them some maps of our trails for their examination.

- The NYS Canal Conference will be held on Oct. 23rd and 24th at Little Falls. There will be many talks on subjects related to the canal trail.

It will be used to leave information about upcoming hikes and where to get maps. Callers can leave a message if they need more info. (Note: the number is 234-8226, starting 8-12-98)
- Dave W. got a phone call from the owner of the lot on Break of Day Rd. that we use to access the Auburn Trail. She doesn't want us using the access to the trail. She is trying to sell the property.
