Ruth reported on a news article appearing in the Huffington Post on-line news regarding corporate sponsorship of state parks, which is one way being explored to provide needed operating funds to our state parks faced with reduced state funding.

## OLD BUSINESS:

Pete reported that the Farmington Town Board will approve a consultant at their March 22 meeting for the Auburn Trail extension through the Town of Farmington. The review and grant writing will take approximately 1 year to complete. Dave Wright, representing VHT, will be on the committee.

VHT is waiting to hear about a grant application submitted to The American Hiking Society for a planned 2011 project to construct a bridge over the small creek connecting the Auburn Trail in Fishers to the Domine Trail.

ADK Outdoor Expo will be June 11<sup>th</sup>. VHT will do a seminar on the trails in Victor.

Advio is offering free digital board advertising to nonprofit organizations. Dave W. will look into this and report back at the next meeting.

The American Hiking Society's 19<sup>th</sup> annual National Trails Day will be June 4<sup>th</sup>. This year's slogan is "Made with all Natural Ingredients". FLCC's Victor Campus on Rt. 251 will be VHT's National Trails Day center. Registration will be from 8 a.m. to 9 a.m. A light breakfast, post hike snack, and lunch will be provided. There will be 3 hikes, each approximately 45 min. to 1 ½ hr. long. Victor Parks & Rec will have a tie-in event at Victor Municipal Park as the last hike of the day.

## NEW BUSINES:

VHT has been invited to speak at a Victor-Farmington Rotary meeting in March, April, or May.

A suggestion for a future VHT bike ride: follow the old Trolley bed's path through the town. *to Fishers & Farmington*

VHT received an e-mail from a property owner on School St. whose property backs up to Ganondagan Park. He would like a trail cut through his property to access the park. A bridge would need to be built. There would be some benefit to this additional park access from School St. but it was decided that further investigation is needed.

Joanie Towarnicky suggested in an e-mail that it would be nice to have an evening social outing centered around a hike accompanied by some wine and food. After some discussion, it was decided to have a "Moonshine Outing" on ~~Friday~~, *Sat* March 18<sup>th</sup>. We will meet at 7 p.m. at Mickey Finn's. Let's hope the full moon isn't hiding behind clouds that evening.
